



HANNAH RECEIVES FIRST SECURITY PROFESSIONAL AWARD

"MOST DESERVING" TAKES 2000 TROPHY

Larry Hannah became the first in our community to receive the Kansas City ASIS Security Professional Award for 2000. The award, which is the result of more than a year of planning, is a way for the Kansas City Chapter to recognize the outstanding efforts of one of our colleagues in the security industry who has contributed to the profession and the community. Chapter Chairman Chris Storms presented the award to Hannah at the monthly meeting February 3 at the Hereford House before about 80 members.

Storms described Hannah's contributions and professional achievements which led to his selection. Storms said that Hannah "is always willing to give his time and talents in order to better the security industry. He spent many hours working for the Chapter as chairman, and organized the chapter committees and files better than they have ever been organized. When leaving the chairman role he was willing to stay on board of KC ASIS to assist the incoming chairman and continue to serve the chapter." A standing ovation and many handshakes and congratulations followed. There seemed to be no doubt among members that the most deserving person received the award.

Hannah earned his Bachelor's degree in Criminal Justice Administration from Central Missouri State University. After college, he worked as a loss prevention manager for Ward's, working in Kansas City, Wichita, and Joplin for eight years. He then became the loss prevention manager for Hall's Merchandising, where he has been for the last 17 years. While at Hall's, he has transformed the security department from a simple guard service to a multi-function department that handles safety, inventory management, and loss prevention investigations. During his years with the Kansas City Chapter, he has served as Treasurer, Secretary, Vice-Chair, and Chairman. He is currently Chairman of the
